ERMAS 2021

The 7th edition, July 28 – 30, 2021, University `Lucian Blaga' from Sibiu, Romania (hybrid format – online & onsite)

Initial document version at 12-03-2021

We invite submission of research papers in Economics for ERMAS 2021 (the seventh annual scientific conference of Romanian academic economists), from both Romanian- and non-Romanian speaking economists. The conference will take place within July 28 – 30, 2021, in a hybrid (online &onsite) format, with the host institution being the Faculty of Economics (FSE), University "Lucian Blaga" from Sibiu (ULBS), Romania. Given the persistent uncertainty on the pandemic developments, participants can choose to either be present at Sibiu during the conference, abiding with all the safety measures in place at that moment, or attend the conference online. In fact, the entire conference, independent of the location of the presenters, will be available online using a dedicated platform.

The submissions will be evaluated and selected by a Scientific Committee composed of Romanian economists with research output recognized internationally. The invited Keynote speakers, as well as all the members of the Scientific and Organizing Committees for ERMAS 2021, are listed on the following page.

Submission instructions

Please submit your paper as a single PDF—including on its first page the paper's title, authors' names and affiliations, an abstract of maximum 200 words, a maximum of 3 JEL codes, and a maximum of 5 keywords—as an attachment to your email sent to ermas2020sibiu@gmail.com (the email remains the same, as 2020th edition was postponed for 2021). The papers can be submitted starting from March 15, 2021. The deadline for paper submissions is May 15, 2021, 23.59 hours GMT+2 (Bucharest's time). If you do not receive a confirmation of your submission in max two-three days, please re-contact us. Each person can submit one single paper, although s/he can be an author of other papers submitted to the conference (by co-authors). In the case of papers with multiple authors, please mention once more in your submission email who is the intended presenter. All papers and presentations will be in English. Foreign economists may also submit papers, although the majority of the contributed presentations is intended to remain by Romanian economists with affiliations from either outside or inside Romania: the final proportion of presentation slots allocated for foreign economists will be determined by the Scientific Committee—based on the overall distribution quality of papers received for evaluation.
